Zia Natural Gas Company offers rebates to save energy and money with space heating, water heating, and insulation in new building construction. Additional information is provided below. When applying for New Construction, please complete Application pages 1, 4, 5 & 6.

Rebates Available:

- \$900 rebate for new construction over 2,000 sq. ft. (all criteria must be met)
 - o Main Heat source must be natural gas of 92% AFUE or higher
 - Water heater must be tankless of at least 0.82 UEF, condensing storage of at least 0.80 UEF, or regular of at least 0.67 UEF
 - Must have natural gas dryer or range
 - O Must have one additional natural gas outlet
 - Insulation with R-50 or greater rating or alternate insulation method meeting Energy Conservation Code
 - Smart Thermostat
- \$600 rebate for new construction 2000 sq. ft. or less (all criteria must be met)
 - o Main Heat source must be natural gas of 92% AFUE or higher
 - Water heater must be tank less of at least 0.82 EF, condensing storage of at least 0.80 EF, or regular of at least 0.67 EF
 - o Must have one additional natural gas outlet
 - Insulation with R-50 or greater rating or alternate insulation method meeting Energy Conservation Code
 - o Smart Thermostat

Eligibility:

- To qualify you must be a prospective customer who will receive natural gas service from Zia Natural Gas Company, as proven by Line Extension agreement and application for service.
- You are responsible for the full cost and installation of the natural gas appliances.
- Appliances must be purchased and installed after **April 1, 2024.**
- Rebates are subject to program funds and processed on first-come, first served basis.
- Zia Natural Gas Company reserves the right to inspect completed installation to verify compliance with the Energy Efficiency Program.

How to Participate:

- 1. Contact a New Mexico-licensed contractor to install your new space and water heating equipment.
- 2. Review program eligibility and requirements with your contractor.
- 3. Have contractor install the new appliances and insulation.
- 4. Submit completed Rebate Application along with a copy of your equipment receipt and/or contractor invoice and two photos: One photo of equipment installed and second photo of equipment manufacturer's decal displaying make, model and serial number. Drop application and documents off at your local Zia office or mail to:
